The Faculty of Veterinary Medicine of the University of Lisbon (FMV-ULisboa) opens a call for applications of 1 (one) Research Fellowships for Graduates (BI), in the area of Education and Digital Technologies, Communication Design, Graphic Design, Information Technologies, Computing or related areas, under the Regulation of Research Scholarships of the University of Lisbon, pursuant to Despacho No. 6238/2020, published in the Diário da República, 2° série, No. 126, July 1st, 2022, and the Statute of the Research Grantee (EBI), under the project "EviEdVet - Promoção do ensino e formação em medicina veterinária baseada na evidência", funded by national funds through the State Budget/FCT and coordinated by Doctor Manuel Magalhães Sant'Ana, Researche, Faculty of Veterinary Medicine, University of Lisbon

#### Renefits

The grantee is awarded the monthly maintenance allowance corresponding to £930,98 according to values of the scholarships awarded directly by FCT, I.P. (<a href="https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM\_2023.pdf">https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM\_2023.pdf</a>). All grantees receive personal accident insurance in relation to research activities, supported by FMV-ULisboa/funding entity. The grantee who is not covered by any social protection regime may ensure the exercise of the right to social security by adhering to the voluntary social insurance scheme, in accordance with the Code of Contributory Schemes of the Social Security System, ensuring the FMV-ULisboa/funding entity the charges resulting from the contributions in accordance with and with the limits provided for in Article 10 of the Statute of the Research Grantee.

## Eligibility criteria

## Selection process

The final ordering of the candidates who complete the selection methods is performed according to the classification scale from 0 to 20 marks, as a result of the weighted arithmetic mean of the quantitative classifications obtained in each selection method:

- Criterion A: Curricular evaluation (CE) 0-20, with the weight of 50%;
  - Degree in the area of the call, with the weight of 40%
  - Relevant profissional experience, with the weight of 10%
- $\bullet$  Criterion B: Motivation letter 0-20, with the weight of 10%
- Criterion C: Other factors considered relevant, namely the participation in congresses in the area of the grant, and involvement in activities under the scope of the project 0-20, with the weight of 10%
- Criterion D: Interview 0-20, with the weight of 30% (limited to four candidates with the highest classification resulting from the application of the criteria A, B and C).

In case the interview is not done, the weight of 30%, ascribed to the interview, is added to the weight of the motivation letter.

For the final decision for the research grant attribution, the candidates will be ordered according to the weighted average of the obtained score in each of the four criteria, as follows:

For a tiebreaker, sorting of the candidates will be done based on the best scores attributed to each one of the evaluation criteria by the following order: criterion A, criterion B, criterion C, criterion D.
