The research grant is intended to finance the realization, by the grantee, of research activities taking place at FMV-ULisboa, which will be the host institution and contracting entity, which without compromising the work can be carried out in collaboration between more than one institution. The duration of the scholarship is 5 months and can not be renewed.

### 1. RECIPIENTS OF SCHOLARSHIPS:

The research grant is intended for the performance of R&D activities to be carried out by a

## 1. WORK PLANS AND SCIENTIFIC ORIENTATION OF SCHOLARSHIP:

The experimental work will be developed in the Image and Communication Department of the Faculty of Veterinary Medicine of the University of Lisbon, under the scientific guidance of Doctor Manuel Magalhães Sant'Ana, principal investigator of the project EVIEDVET from the Laboratory of Animal Behaviour and Welfare of the Centre for Interdisciplinary Research in Animal Health. The scholarship holder will participate in research and development activities, such as:

- Video creation and editing
- Image editing.
- Website design.
- Management of Learning Management System (e.g., Moodle)
- Elaboration of digital educational resources (e-learning course).
- Management of social networks.

## 1. EVALUATION CRITERIA AND BONUSES

The final ordering of the candidates who complete the selection methods is performed according to the classification scale from 0 to 20 marks, as a result of the weighted arithmetic mean of the quantitative classifications obtained in each selection method:

- **Criterion A:** Curricular evaluation (CE) – 0-20, with the weight of 50%;
  - Degree in the area of the call, with the weight of 40%
  - Relevant professional experience, with the weight of 10%
- **Criterion B:** Motivation letter 0-20, with the weight of 10%

The jury shall assess the applications in accordance with the evaluation criteria contained in this call for applications announcement, considering the elements of evaluation. For each application, a final evaluation report will be produced where it is stated in a clear, coherent and consistent manner the reasoning that led to the scores assigned to each criterion and subcriterion. Minutes of the jury meetings shall be produced and will be the responsibility of all its members.

### 1. DISSEMINATION OF RESULTS:

The results of the evaluation are communicated via e-mail to the email address used by the applicant for the application or indicated in the application.

### 1. DEADLINES AND PROCEDURES OF PRIOR HEARING, COMPLAINT AND APPEAL:

After communication of the provisional list of the evaluation results, candidates have a period of 10 working days, if they wish, to give their opinion at a prior hearing of interested parties, in accordance with Articles 121. of the Code of Administrative Procedure. A claim may be lodged within 15 working days or, alternatively, an appeal may be lodged within 30 working days, both counted from their notification. Applicants who choose to submit a complaint must address their pronouncement to the Rector of the University of Lisbon. Applicants who choose to appeal must address the appeal to the funding entity.

### 1. SCHOLARSHIP AWARD REQUIREMENTS

Research grant contracts are signed directly with FMV-ULisboa. The following documents must be sent, at the time of granting the scholarship, for the purposes of contracting:

- a) Copy of the civil, fiscal and, when applicable, social security identification document(s);
- b) Copy of the certificates of qualification of academic degrees;
- c) Presentation of the registration or recognition of foreign academic degrees and conversion of the respective final classifications to the Portuguese classification scale, if applicable;

- d) Document proving enrollment in a bachelor's, master's or course that does not confer an academic degree identified in this Notice;
- e) Statement by the supervisor(s) assuming responsibility for supervising the work plan, under the terms of article 5.º-A of the Estatuto do Bolseiro de Investigação;
- f) Updated document proving compliance with the regime of exclusive dedication (draft of declaration to be made available by FMV-ULisboa).

Failure to deliver any of the documents required to complete the scholarship contracting process, within a period of 6 months from the date of communication of the decision to conditionally grant the scholarship, implies the forfeiture of the grant and the closure of the process.

#### 1. SCHOLARSHIP CONTRACT AND SIGNATURE TERM

The scholarship contract will be presented in the writing form and must include:

1. The identification of the grantee and the scientific advisor;
2. the identification of the host and funder;
3. the identification of the applicable regulation;
4. The plan of activities to be developed by the grantee;
5. An indication of the duration and start date of the scholarship;
6. The amount of the scholarship.

After receiving all the documents necessary for the conclusion of the contract, the contract shall be signed within 90 working days, suspending the period counting whenever the procedure is halted because it is not attributable to it. In the 15 working days following the date of the reception of the research grant contract, the grantee must return it duly signed. The Scholarship Statute is automatically granted with the conclusion of the contract, always referring to the start date of the scholarship.
